

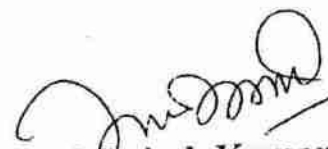

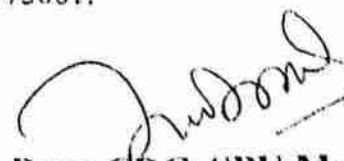
Corrigendum
